

# GRINTON & ELLERTON ABBEY PARISH COUNCIL

The minutes of Grinton & Ellerton Abbey Parish Council held on Monday 2 March 2026 at 7.00pm in Grinton Parish Hall

**1. To receive apologies for absence**

None

**2. To Co-opt new Councillor**

Christine Hird, was welcomed as the new co-opted councillor for the parish. The Declaration of Acceptance form was duly signed and countersigned by the Parish Clerk. The Pecuniary Interests form is to follow.

**3. To confirm minutes of meeting held on 5 January as a true and correct record**

The minutes of the last meeting held on 5 January 2026 were approved as a true record and signed by the Chair.

**4. To receive information on the following ongoing issues and decide further action where necessary**

**4.1 Grinton Bridge River Level Recorder**

The Environment Agency has issued a draft agreement covering the RLR at Grinton Bridge. The following amendments needed were highlighted:-

- The name of the council to include Ellerton Abbey
- The parish council's contact address to be amended
- Title of signatories to be amended
- Amendment to attached plan showing parish land

The Parish Clerk to contact the Environment Agency and request the above amendments to be made to the agreement

**4.2 20mph Speed Limit Proposal**

Highways have been in contact about the date of the speed surveys to be held in Grinton. The "tubes" will be set up in 4 locations and be active from 16 March 2026 for 7 days. Highways will then speak to the police and update the council as to the proposed way forward,

**4.3 Hags Gill Corner – Overgrown Trees**

Cllr Matt Baker attended a site meeting with Highways late January and highlighted the issues with the overgrown trees at Hags Gill Corner. Highways are now waiting for prices before proceeding with the work.

#### **4.4 Highways Maintenance – Crackpot Road**

Once again the problem with potholes between Crackpot to Spring End has been taken up with Highways. Apologies were received as it was recognised that the matter has been reported a number of times. The Highways Project Engineer has said an inspection will be made of the section of road in question upon which an order will then be placed with their contractor for the repair of any damage that meets their intervention order.

#### **4.5. Grinton Gill Riverbank**

There has been further damage to the bank since the last meeting in January but not to the point of intervention. It was decided to keep monitoring the beck.
